1. That a proposal was filed with us on the 13th day of January 2023 a copy of which is attached and marked as Exhibit "A", and that we filed a copy of the proposal with the official receiver on the 13th day of January 2023.
2. That on the 18th day of January 2023, we gave notice to the debtor, to the division office and to every known creditor affected by the proposal, whose names and addresses are shown in Exhibit "B" to this report, of the calling of a meeting of creditors to be held on the 2nd day of February 2023 to consider the proposal.
3. That with the notice was included a condensed statement of the assets and liabilities of the debtor, a list of the creditors affected by the proposal who have claims of \$250 or more and showing the amounts of their claims, a copy of the proposal, a form of proof of claim and proxy in blank and a voting letter. Copies of the notice, the condensed statement and the list of creditors are attached and marked as Exhibits "C1", "C2" and "C3", respectively.



MINUTES OF THE FIRST MEETING OF CREDITORS

Harman Jaswal took attendance prior to the start of meeting. Please see attendance list for list of those present online and in person.

The Chairman calling the meeting to order at 10:03 AM declared the meeting properly called, and a quorum being present via phone, duly constituted.

The Chairman introduced himself and the Trustee's staff in attendance. Also introduced was Mr. Jim Lawson – Chief Financial Officer of the BR Capital Group and the representative of the Companies, Randal Van de Mosselaer of Osler Hoskin & Harcourt LLP, counsel to the Proposal Trustee and Tom Cumming of Gowling WLG, counsel to BR Capital Group.

Neil Honess acted as Chairman under the authority of Section 51(3) of the *Bankruptcy and Insolvency Act*.

The following documents were tabled and available for review:

- Certificate of Appointment;
- Statement of Affairs;
- Proposal;
- Proof of Service of the notice calling the first meeting of creditors; and
- Trustee's report on the financial situation of the debtor and on the proposal.

PURPOSE OF THE MEETING

The Chairman explained that the purpose of the meeting of creditors is to consider the affairs and proposal of the debtor and to vote on the Proposal.

The Chairman provided the following details and summary to the Meeting with regards to the Trustee's report on the financial situation of the Debtor and on the Proposal;

- Due to the COVID-19 pandemic, certain key contract negotiations between BR Capital Group and potential customers were halted or cancelled. This resulted in a large decrease in revenue, and BR Capital Group was unable to service liabilities due to noteholders.
- The constituent entities within the BR Capital Group filed Notice of Intention's on September 15, 2022 and September 16, 2022 to make a Proposal to its creditors pursuant to the Bankruptcy and Insolvency Act.
- On January 13, 2023, BR Capital Group filed the Proposal.
- BR Capital Group's primary assets as at the date of the Proposal are cash and some accounts receivable, with a total book value of approximately \$75,000.
- BR Capital Group's primary liabilities as at the date of the Proposal notes payable, deferred management compensation, trade creditors, the CRA, and amounts due to employees.
- The Proposal calls for the pro-rata issuance of units in BR Capital LP, in exchange for extinguishment of outstanding unsecured liability amounts. BR Capital Group would then continue operations with a future potential of return to unitholders.
- In addition, the levy payable to the Office of the Superintendent of bankruptcy shall be paid in cash; calculated on the enterprise value of the business as valued on a going concern basis.
- The Proposal provides that the statutory terms of sections 95 to 101 of the BIA, and similar provisions, shall not apply as permitted by section 101.1 of the BIA.
- The Proposal shall be deemed to be accepted by the creditors, only if majority in number and two thirds in value of the affected creditors vote for the acceptance of the Proposal.
- In the event that the creditors reject the Proposal, all entities within the BR Capital Group will automatically become bankrupt, and its assets liquidated by the bankruptcy trustee. No value is expected for intellectual property under a forced liquidation scenario.
- If the BR Capital Group becomes bankrupt, the estimated recovery for the affected creditors would be zero.

QUESTIONS

The Chairman opened the meeting to questions from the creditors with respect to the Trustee's Report and the Proposal, either directed at the Trustee or Mr. Lawson.

Q: Amy Reid (whom filed a Proof of Claim against the Directors which was disallowed) asked the following:

- The whereabouts and storage of specific employee documents; and
- Reasoning behind multiple affidavits.

A: Mr. Lawson, in regard to the employee records confirmed;

- The records of the company are in storage and in online data basis; and
- Paper copies are being stored between Mr. Lawson's residence and the residence of HR/Accounting.

Amy Reid interjected questioning the validity of those residences being listed as businesses however the Chairman intervened stating the question was not relevant to the proposal.

A: In regards to the multiple affidavits, the Chairman stated the question is not relevant to the proposal and questions should be limited to the proposal.

There were no further questions from the creditors.

CLAIMS REGISTER, PROXIES AND VOTES

The Chairman read out the proofs of claims, proxies and votes received prior to the meeting. Debbie Mitchell from CRA asked to confirm if we received the CRA's proof of claim which the Chairman confirmed we did.

The Chairman noted the following with regards to the claims and proxies received:

- The Trustee has disallowed the proof of claim submitted by Amy Reid and accordingly marked as disputed for now. Amy Reid was still allowed to vote in the meeting and subsequently voted "against".

VOTING ON THE PROPOSAL

The Chairman noted the following to the meeting:

- Vote to be held;
- Votes are counted 1 per creditor and dollar amount;
- For Proposal to be accepted need 2/3 in value and majority in number;
- We need to consider the results without the Related Party votes; and
- If any votes are against adjourn meeting shortly to discuss.

The Chairman opened the meeting to anyone on the call or in person who would like to submit a vote or change a previously submitted vote.

Amy Reid cast her vote "against" the proposal.

Representative from Minden Gross LLP, attending the meeting on behalf of Copper Lake Holdings, cast its vote "against" the proposal.

The Chairman pointed out that since Copper Lake Holdings had not submitted a proof of claim, its vote was noted as disputed.

All other creditors in attendance in person or by proxy voted “for” the proposal.

APPOINTMENT OF INSPECTORS

The Chairman advised that inspectors are appointed as representatives of all creditors in this matter and work with the Trustee to provide input on the various decisions that have to be made from time to time. The BIA provides for up to 5 Inspectors to be appointed. The Chairman also advised that:

- Employees, officers and directors are not permitted to vote for inspectors;
- Related party votes to be counted separately; and
- Parties involved in active actions against the company cannot be Inspectors (s116(2)).

There was no motion made by the creditors for the appointment of Inspectors of the Division I Proposal.

ADJOURNMENT

As all matters were concluded, the Chairman proposed to adjourn the meeting. Warshawski Joseph motioned to adjourn the meeting. No one voted against, and the meeting was adjourned at 10:32 AM.
