#### **RECITALS**

- A. Pursuant to the Notice of Intention to Make a Proposal of DecisionOne Corporation ("**D1 Canada**") dated May 19, 2023 filed pursuant to the *Bankruptcy and Insolvency Act*, KPMG Inc. was appointed as the trustee of the proposal (the "**Proposal Trustee**") of D1 Canada.
- B. Pursuant to an Order of the Ontario Superior Court of Justice (Commercial List) (the "Court") dated June 5, 2023 (the "Order"), the Court approved the Asset Purchase Agreement made as of May 22, 2023 (the "Sale Agreement") between D1 Canada and STC Lender LP.
- C. Pursuant to the Sale Agreement, STC Lender LP assigned all of its rights, interests and obligations under the Sale Agreement to D2 Assets Canada Inc. (the "**Purchaser**").
- D. The Order granted by the Court provided for the vesting in the Purchaser of D1 Canada's right, title and interest in and to the Purchased Assets (the "**Transaction**"), which vesting is to be effective with respect to the Purchased Assets upon the delivery by the Proposal Trustee to the Purchaser of a certificate confirming (i) the satisfaction by the Purchaser of the Purchase Price for the Purchased Assets; (ii) that the conditions to Closing as set out in Article X of the Sale Agreement have been satisfied or waived by D1 Canada; and (iii) the Transaction has been completed.
- E. Unless otherwise indicated herein, terms with initial capitals have the meanings set out in the Sale Agreement.

### THE PROPOSAL TRUSTEE CERTIFIES the following:

- 1. The Purchaser and D1 Canada have confirmed to the Proposal Trustee in writing that the Purchaser has satisfied the Purchase Price for the Purchased Assets on Closing pursuant to the Sale Agreement;
- 2. The Purchaser and D1 Canada have confirmed to the Proposal Trustee in writing that the conditions to Closing as set out in Article X of the Sale Agreement have been satisfied or waived by D1 Canada and the Purchaser; and
- 3. The Transaction has been completed.
