	The signature of the claimant must be witnessed. A complete address must be provided including the postal code where all notices and correspondence are to be forwarded.
	The amount on the statement of account must agree with the amount claimed on the proof of claim.

	The creditor must state the full and complete legal name of the Company or the claimant. If the individual completing the proof of claim is not the creditor himself, he must state his position or title.
РΑ	RAGRAPH 3 OF THE PROOF OF CLAIM
	A detailed statement of account must be attached to the proof of claim and must include the date, the invoice number and the dollar amount of all invoices or charges, together with the dates, the number and the amount of all credits or payments. A statement of account is not complete if it begins with an amount brought forward. In addition, a creditor must indicate his/her address, phone number, fax number rand e-mail address.
