(Fee Approval)**

**THIS MOTION**, made by KPMG Inc., in its capacity as The Trustee of the Estate of MF Global Canada Co., a bankrupt (in such capacity as the “Trustee”) was heard this day at 330 University Avenue, Toronto, Ontario.

**ON READING** the Notice of Motion, the eighth report of the Trustee dated August 19, 2016 (the “**Eighth Report**”), Report #3 of the Independent Cost Counsel dated August 16, 2016 (the “**ICC Third Report**”), the fee affidavit of Jordan Sleeth sworn August 19, 2016, the fee affidavit of Kyle B. Plunkett sworn August 19, 2016, and on hearing the submissions of counsel to the Trustee, and the submissions of the Independent Cost Counsel appointed pursuant to the Order of Mr. Justice Campbell dated November 23, 2012 (the “**ICC**”), no one else appearing although duly served as set out in the Affidavit of Service of Kyle B. Plunkett dated August 23, 2016, filed.

**SERVICE**

1. **THIS COURT ORDERS** that the time for service and filing of the Notice of Motion and the Motion Record is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.

**APPROVAL OF EIGHTH REPORT**

2. **THIS COURT ORDERS** that the Eighth Report and the activities set out therein, be and are hereby approved.

**APPROVAL OF ICC REPORT**

3. **THIS COURT ORDERS** that the ICC Third Report be and is hereby approved.

**APPROVAL OF FEES AND DISBURSEMENTS**

4. **THIS COURT ORDERS** that the accounts of the Trustee for the period from February 1, 2015 to May 31, 2016 (the "**Trustee Fee Period**"), including fees in the amount of \$359,727.25 and disbursements in the amount of \$18,919.55 (plus applicable HST on the foregoing amounts) for services rendered and recorded during the Trustee Fee Period be and the same are hereby approved.

5. **THIS COURT ORDERS** that the accounts of Borden Ladner Gervais LLP ("**BLG**"), the lawyers for the Trustee, for the period from February 1, 2015 to May 31, 2016 (the "**BLG Fee Period**"), including fees in the amount of \$483,057.50 and disbursements in the amount of \$70,395.25 (plus applicable HST on the foregoing amounts) for services rendered and recorded during the BLG Fee Period be and the same are hereby approved.

**GEISWEILLER CLAIM**

6. **THIS COURT ORDERS** that the Trustee be and is hereby authorized to accept the Proof of Claim of Mr. Frederic Geisweiller in the amount of \$32,314.00 in accordance with the Customer Pool Fund Re-Allocation Order of Mr. Justice Morawetz dated December 9, 2013 and make a distribution to Mr. Frederic Geisweiller from the Customer Pool (as that term is defined in the Eighth Report) in the amount of \$32,314.00 forthwith following the issuance of this Order.

**APPROVAL OF CIPIF LEGAL FEES**

7. **THIS COURT ORDERS** that the Trustee is hereby authorized and directed to reimburse the Canadian Investor Protection Fund for its out of pocket legal fees in the amount of \$379,111.75 for its assistance to the Trustee in the administration of the Estate of MF Global Canada Co., as described in the Eighth Report.
