IN THE MATTER OF THE NOTICE OF INTENTION TO MAKE A PROPOSAL OF 2581751 ONTARIO INC OF THE CITY OF TORONTO IN THE PROVINCE OF ONTARIO

To the creditors of 2581751 Ontario Inc.:

Notice is hereby given that 2581751 Ontario Inc. ("Liberty LeaseCo" or the "Company") filed a Notice of Intention to Make a Proposal ("NOI") on March 5, 2024 (the "Filing Date"), pursuant to section 50.4(1) of the *Bankruptcy and Insolvency Act* (the "BIA"). KPMG Inc. ("KPMG") was named as trustee under the Company's NOI (the "Proposal Trustee"). As a result of the NOI filing, the Company has obtained the benefit of a stay of proceedings under section 69.1(1) of the BIA, and all creditors are stayed from commencing or continuing any proceedings against the Company.

The purpose of the Company's NOI proceedings is to provide a stable environment within which Liberty LeaseCo can pursue a sale of the Company's business and/or assets through a Court-supervised process and consider the development of a proposal to its creditors.

KPMG's role as Proposal Trustee in this matter is to monitor the proceedings, monitor the Company's receipts and disbursements, liaise with creditors and to assist with the development of a proposal to creditors (a **"Proposal"**), should one be put forward.

A copy of the NOI and a list of creditors with claims amounting to \$250 or more as known or shown by the books and records of the Company on the Filing Date are attached hereto. Please note that the enclosed creditor lists are preliminary and subject to change.

The Proposal Trustee notes that the Company is not bankrupt, but has availed itself of a procedure whereby a company, with creditor and Court approval, may restructure its financial affairs. At this time, creditors are not required to file a proof of claim with the Proposal Trustee. In due course, the Proposal Trustee will provide creditors with additional information regarding the NOI proceedings, including, if necessary, information concerning the filing of a proof of claim and the date for a meeting of creditors to consider and vote on a Proposal, should one be put forward to creditors.
