1. 2009 Long Lake Holdings Inc. ("**2009 Long Lake**") filed an assignment on the 29th day of September 2022 and the undersigned, KPMG Inc., was appointed as trustee of the estate of the bankrupt by the official receiver, subject to affirmation by the creditors of the trustee's appointment or substitution of another trustee by the creditors.
2. 65 Larch Holdings Inc. ("**65 Larch**" and together with 2009 Long Lake, "**2009 Long Lake et al.**"), also filed an assignment on the 29th day of September 2022, and KPMG Inc. was appointed as trustee of the bankrupt estate by the official receiver, subject to affirmation by the creditors of the trustee's appointment or substitution of another trustee by the creditors.
3. Pursuant to an Order of the Ontario Superior Court of Justice [Commercial List] dated July 15, 2022, the trustee is authorized, among other things, to carry out its administrative duties and responsibilities as if the bankruptcy proceedings of 2009 Long Lake et al. were a single proceeding under the *Bankruptcy and Insolvency Act* (Canada). As such, the first meeting of creditors in the 2009 Long Lake proceedings will be consolidated with the first meeting of creditors of the 65 Larch proceedings.
4. The first meeting of creditors for 2009 Long Lake et al. will be held on the 19th day of October 2022 at 11:00 AM at Virtual Meeting or Conference ID: 90096637#, 647-794-1236.
5. To be entitled to vote at the meeting, a creditor must lodge with the trustee, before the meeting, a proof of claim and, where necessary, a proxy.
6. Enclosed with this Notice is a proof of claim form, proxy form and a list of creditors with claims amounting to \$25.00 dollars or more showing the amounts of their claims.
7. Creditors must prove their claims against the estate of the bankrupt in order to share in any distribution of the proceeds realized from the Estate.
