#### **ORDER**

THIS MOTION by YUCHUAN SHAO, SANLIN SHAO, JUN XING and JIANZHONG XING (the "Moving Parties") seeking an order lifting the stay of proceedings in various bankruptcy and receivership proceedings was heard this day via videoconference at Toronto, Ontario.

UPON reading the Amended Notice of Motion of the Moving Parties, the Affidavit of Jun Xing sworn June 3, 2022 and exhibits filed, the Affidavit of Jianzhong Xing sworn June 27, 2022, and the Affidavit of Spencer Frederick Toole sworn September 16, 2022 and exhibits filed; and upon reading the affidavit of Allan Fogul sworn January 30, 2022 and exhibits filed; and upon reading the Motion Record of Yi Jin and Awei Liu including the affidavits contained therein in a related motion heard this day brought in this court file number 31-2747949; and upon reading the Responding Report of KPMG Inc., the receiver and manager of Southmount Healthcare Centre Inc. et al., and of Victoria Avenue North Holdings Inc., and the Trustee of the estates of 65 Larch

Holdings Inc., 2009 Long Lake Holdings Inc., 100 Colborne Holdings Inc., 240 Old Penetanguish Holdings Inc. and 2478658 Ontario Ltd., all bankrupt (collectively in those capacities, "**KPMG**");

AND UPON hearing the submissions of counsel acting as agent for the litigation counsel for the Moving Parties; and counsel for KPMG; no one appearing for Deloitte Restructuring Inc. ("Deloitte"), for KSV Restructuring Inc., the trustee of the estates of Gross Capital Inc. and of Sheldon Gross Limited, both bankrupt ("KSV"), or for the Office of the Superintendent of Bankruptcy, although duly served;

- 1. **THIS COURT ORDERS** and declares that, subject to paragraphs 3 through 6 below, the stay of proceedings pursuant to Section 69.3 of the *Bankruptcy and Insolvency Act* (the "*BIA*") in each of the following estates:
  - a. 31-2747949 Bankruptcy of Gross Capital Inc.;
  - b. 31-2810419 Bankruptcy of Sheldon Gross Limited;
  - c. 31-2842640 Bankruptcy of 100 Colborne Holdings Inc.;
  - d. 31-2842641 Bankruptcy of 240 Old Penetanguish Holdings Inc.; and
  - e. 32-2842635 Bankruptcy of 2478658 Ontario Ltd.
  - f. 31-2869843 Bankruptcy of 2009 Long Lake Holdings Inc.
  - g. 31-2869845 Bankruptcy of 65 Larch Holdings Inc.

(collectively, the "Bankruptcy Estates") shall no longer operate in respect of the action commenced by the Moving Parties against Mark Gross, Sheldon Gross, and numerous corporate defendants set out in Schedule "B" hereto (collectively, the "Defendants") and that the Moving Parties are authorized to commence and continue to prosecute their action

- no. CV-21-00666297-0000 commenced in the Superior Court of Justice at Toronto (the "Action"), *nunc pro tunc*.
- 2. **THIS COURT ORDERS** and declares that, subject to paragraphs 3 through 6 below, the stay of proceedings pursuant paragraphs 8 and 9 of the following Appointment Orders of this Court in:
  - a. Court File No. CV-21-00656098-00CL dated March 9, 2021;
  - b. Court File No. CV-21-00664273-00CL dated June 29, 2021; and
  - c. Court File No. CV-21-00665375-00CL dated August 3, 2021
  - (collectively, the "Receivership Orders") shall no longer operate in respect of the Action, and that the Moving Parties are authorized to commence and continue to prosecute the Action, *nunc pro tunc*.
- 3. THIS COURT ORDERS that the right of the Moving Parties to commence and continue to prosecute the Action as against the bankrupts in any of the Bankruptcy Estates (collectively, the "Bankrupts") or as against the respondents in any of the Receivership Orders (collectively, the "Receivership Respondents") (without limiting of the Moving Parties' rights as against any of the other Defendants) shall be for the purpose only of establishing the amount for which the Moving Parties are entitled to prove in the Bankruptcy Estates and/or the receiverships in the proceedings referenced in subparagraphs 2(a) through (c) (collectively, the "Receiverships") as an unsecured claim, such that, for greater certainty, the enforcement of any Judgment obtained by the Moving Parties as against any of the Bankrupts

or Receivership Respondents or their respective property remains stayed pending further Order of this Court.

- 4. THIS COURT ORDERS that nothing in this Order shall be deemed to require KSV, KPMG, or Deloitte (collectively, the "LITs") to defend the Action or the Judgment sought therein, or to take any other steps in respect of the Action or the Judgment sought therein, including, without limitation, production of documents (subject to further Order of this Court, provided that all reasonable fees and expenses incurred by any of the LITs in attempting to locate, locating and/or providing any such documents, as applicable, shall be paid jointly and severally by the Moving Parties to that LIT, including without limitation, at the regular hourly rates of those representatives of the LIT engaged with such tasks and any reasonable disbursements (including, without limitation, legal fees) in connection with same) or participating in any discovery proceedings or similar proceedings.
- 5. **THIS COURT ORDERS** that, provided that an LIT does not defend the Action, that LIT shall not be liable (in its corporate capacity or in its capacity as the trustee or receiver) for any costs with respect to the Action or the Judgment sought therein.
- 6. **THIS COURT ORDERS** that, in the event that any of the non-bankrupt Receivership Respondents hereafter becomes bankrupt, the terms of this Order shall apply to lift the stay of proceedings under s.69.3 of the *BIA* in any such bankruptcy estate as if the estate of the bankrupt Receivership Respondent is included in the list of bankruptcy estates enumerated in paragraph 1 and defined herein as the "Bankruptcy Estates".

7. **THIS COURT ORDERS** that a copy of this Order shall be placed in each of the Court Files listed on Schedule "A".
