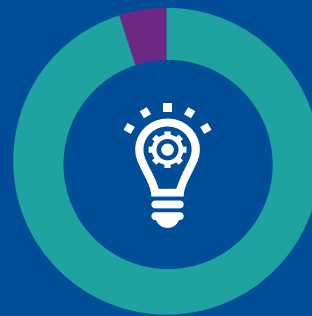

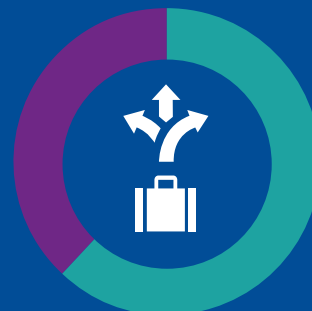
The power of digital disruption
