Tourism – Notification No. 266 on the implementation of additional measures of the Royal Government for the exemption of the fees for the renewal of all types of tourism licenses for the year 2021

Ministry of Tourism (MoT) – Notification No. 266 on the implementation of additional measures of the Royal Government for the exemption of the fees for the renewal of all types of tourism licenses for the year 2021

On 08 June 2020, the MoT has informed to the Tourism Industry Association (TIA) and all tourism business owners as follows:

1. Exempt the fees for the renewal of all types of valid tourism licenses for the year 2021.
NOTE: All tourism businesses must still apply for the renewal of tourism licenses from the MoT or municipal/provincial administrations or commune, district or capital administrations (depending on the size of the tourism businesses) during the exemption period.
2. Maintain the fees for:
 - all types of tourism businesses which apply for new tourism licenses or renewals for the year 2020; and
 - all types of tourism businesses which apply for new tourism licenses for the year 2021.
3. Maintain the payment of public service fees to apply for all types of tourism services.
4. Maintain the implementation of transitional financial penalties for any expired tourism licenses and tourism businesses which have committed any offenses as stipulated in Annex 3 of the Joint Prakas No. 160 dated 17 February 2020 on public services fees and financial penalties by the MoT, except for the payment of public service fees for the renewal of tourism licenses for the year 2021 which are exempted.
5. The exemption of the fees for the renewal of all kinds of tourism licenses shall be implemented from 01 January 2021 to 31 December 2021.
