

## Telecommunications - mergers and acquisitions

### Telecommunication Regulator of Cambodia (“TRC”) – Instruction No. 1252 dated 30 June 2020 on company merger, company or share acquisition or creating security rights defined in permits, certificates or licenses and updating the information of telecommunications operators’ management (focal person) (“Instruction”)

In accordance with the Law on Telecommunications Articles 22 and 63, the Telecommunications Regulator of Cambodia (TRC) has informed all telecommunications operators as follows:

- For company mergers, company or share acquisitions or creating security rights defined in permits, certificates or licenses, telecommunications operators must obtain the approval from the TRC by following the procedures stated in the Law on Telecommunications.
- For changing the company name or address, telecommunications operators must submit a request to the TRC to update the name or address on the business license by attaching the approval letters from the relevant authorities and paying the official public service fee.
- Telecommunications operators must notify the TRC immediately for the change of Memorandum and Articles of Association (M&A), chairman or members of the board of the directors, executive, finance and technical directors, or focal person of the company.
- The information of shareholders, chairman of the board of the directors, executive, finance and technical directors and focal person of the company must be submitted to the TRC annually before the end of December. For the information for 2020, the company must submit to the TRC within seven working days after the signing date of this instruction, 30 June 2020.
