



## Commerce - Announcement on Authorisation to a Representative or an Agent for Business Registration

### Ministry of Commerce (“MoC”) – Announcement No. 1497 dated 5 July 2021 on the authorisation to a representative or an agent for business registration.

On 5 July 2021, the MoC issued an announcement that all investors / business owners of any entity type can register their business by themselves through the MoC online system ([www.registrationservices.gov.kh](http://www.registrationservices.gov.kh)). However, if the investors / business owners wish to register their business as a Partnership or Limited Liability Company by seeking assistance from a representative, that representative must be an agent accredited by the MoC.
