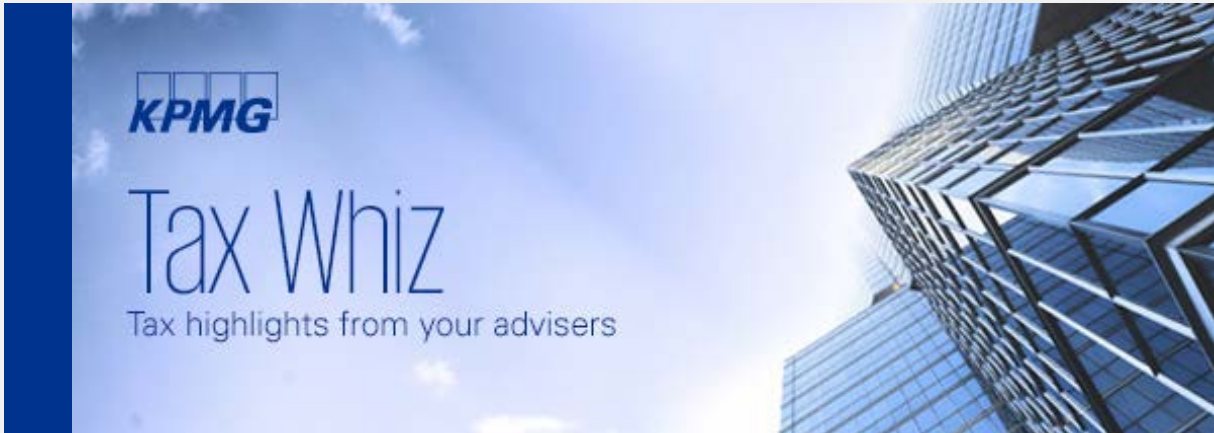


Subject: Tax Whiz | Extension of the Special Voluntary Disclosure Programme ("SVDP")

Dear Valued Client / Business Associate,

Extension of the Special Voluntary Disclosure Programme ("SVDP")

The Ministry of Finance ("MOF") has recently issued a [media release](#) that the reduced penalty rate of 10% given for the first phase of the SVDP from 3 November 2018 to 31 March 2019 is now extended to 30 June 2019.

The subsequent phase of the SVDP will commence from 1 July 2019 to 30 September 2019 and the reduced penalty rate offered is 15%. After the SVDP, the minimum penalty rate in respect of failure to submit tax return and under-declaration of income tax is 45%.

The SVDP applies to assessment of income up to Year of Assessment 2017 for individuals and up to financial year ended 31 March 2018 for companies.
