ON THE APPLICATION of Integris Credit Union, a creditor, coming on for hearing before me this day at the Courthouse, 800 Smithe Street, Vancouver, British Columbia; AND ON HEARING Colin D. Brousson, Counsel for the Applicant creditor, Integris Credit Union; and no one else appearing although duly served; AND ON READING the material filed herein to date;

AND it appearing to the Court that the following acts of bankruptcy have been committed:

- (a) All-Wood Fibre Ltd. has ceased to meet its liabilities generally as they become due; and
- (b) All-Wood Fibre Ltd. it has permitted a seizure of its property to remain unsatisfied until within five (5) days of the date fixed for the sale or fifteen (15) days from the date of seizure.

1. The Court hereby orders that All-Wood Fibre Ltd., of 9453 Rock Island Rd., Prince George, British Columbia be adjudged bankrupt by virtue of a bankruptcy order hereby made on this date.

2. The Court further orders that KPMG Inc. of 200 - 206 Seymour Street, Kamloops, British Columbia, V2C 6P5, be appointed as Trustee of the estate of the bankrupt.

3. ~~The Court further orders that the Trustee give security in cash or by bond or suretyship without delay, in accordance with subsection 16(1) of the Act.~~

4. ~~The Court further orders that the costs of the applicant be paid out of the estate of the bankrupt on taxation of the estate.~~
