3. **THIS COURT ORDERS** that the accounts of Gardiner Roberts LLP, the Independent Cost Counsel appointed by Order of Mr. Justice Campbell dated November 23, 2012, for the period from April 6, 2015 to May 4, 2015 (the “**ICC Fee Period**”), for fees and disbursements in the amount of \$9,514.50 (plus applicable HSAT on the foregoing amount) for services rendered and recorded during the ICC Fee Period be and the same are hereby approved.
