### Germany: Issued CRS Newsletter 07/2019

On 30 July 2019, the Federal Central Tax Office of Germany (BZSt) released a newsletter, 'Infobrief CRS 07/2019', providing information to the Reporting Financial Institutions (FIs) about the correction of the error mentioned in 'Infobrief 06/2019'. Due to this error, deletion, correction and cancellation deliveries received by the BZSt between 29 May 2019 and 21 July 2019 were incorrectly rejected with an error code "CRS\_E\_MESS\_049". The error was rectified by a system adjustment.

Additionally, the BZSt informs that all the deliveries received between 29 May 2019 and 21 July 2019 for which the error code "CRS\_E\_MESS\_049" was issued, will be reprocessed at the beginning of August 2019, and the Reporting FIs would receive another processing protocol. However, if the new processing protocol still contains the error "CRS\_E\_MESS\_049", the error was not due to faulty system behavior and the submitting agencies need to reexamine and resubmit Reporting FIs data.

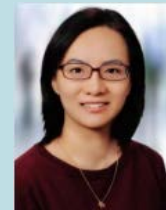
