Liechtenstein: Approved implementation of automatic exchange of information with Oman, Kazakhstan and Ecuador

On 09 December 2019, the Tax Authority of Liechtenstein issued Gazette No.332, 333 and 334, notifying the public about the introduction of automatic exchange of information for financial accounts with Ecuador, Kazakhstan and Oman. The first exchange of financial data with these three jurisdictions will take place in 2021, for information from the 2020 reportable year.
